# Terms of the licence

If no other terms or conditions for the use of materials have been set in writing or if no other terms or conditions have been set in the service related to the material or during the distribution of the material, the right of use will be granted for the material with the following terms and conditions:

Rights of use

This licence grants the user a global, irrevocable parallel limited right of use. According to the terms of the licence, the material or service specified in the title can be used for the following personal purposes or for <u>internal</u> use within an organisation:
